RELEASE, AGREEMENT AND COVENANT NOT TO SUE  
For Cherokee County Humane Society

This release and covenant not to sue is executed and delivered by the undersigned volunteer (volunteer), at Cherokee County, Georgia to and in favor of the Cherokee County Humane Society, a Georgia Non-Profit Corporation, (Cherokee County Humane Society).

WHEREAS, Cherokee County Humane Society operates a non-profit corporation and organization for the prevention of cruelty to animals and related purposes; and

WHEREAS, the undersigned volunteer wishes to perform services on a voluntary basis for the Cherokee County Humane Society, in Cherokee County, Georgia and elsewhere, and assumes the risk of damage and injury to property or person (of volunteer).

The undersigned volunteer, to be allowed to perform such services for the Cherokee County Humane Society, as may be appropriate, promises, agrees and covenants, as follows:

Volunteer will never institute any action or suit at law or in equity against the Cherokee County Humane Society, nor institute, prosecute or in any way aid, assist or participate, directly or indirectly in the institution or prosecution of any claim, demand, action or cause of action for damages costs, loss of services, expenses, or compensation for or on account of any damage, loss or injury either to person or property, or both, whether developed or undeveloped, resulting or to result, known or unknown, past present or future, arising out of the condition or operation of the Cherokee County Humane Society (including, but not limited to, any damage, loss or injury either to person or property, or both, resulting from contact with or the actions or conduct of any animal in the custody or control of or in connection with the Cherokee County Humane Society). The undersigned volunteer further hereby releases, demises, and discharges the Cherokee County Humane Society and covenants and agrees to defend, indemnify and hold the Cherokee County Humane Society harmless of and from any and all of the foregoing, including but not limited to actions, causes of action, claims, demands, damages, suits, costs, expenses said volunteer has, had or may have for any reason or which may occur or arise by reason of volunteer's association, activity or work now, heretofore or hereafter with the Cherokee County Humane Society.

This covenant and release shall inure to and for the benefit of the Cherokee County Humane Society, itself and related organizations, its successors and assigns, officers, agents, directors, employees, (other) volunteers and representatives; and shall bind the undersigned volunteer, volunteer's successors and assigns, spouse, heirs, executors, administrators and representatives.

This instrument reflects the entire covenant and release agreement and understanding of the parties, and no statements, promises or inducements made by or on behalf of the Cherokee County Humane Society not contained herein shall be valid or binding.

The undersigned volunteer executes and delivers this release and covenant not to sue agreement and instrument in order to induce the Cherokee County Humane Society to permit volunteer to perform service and work as an unpaid volunteer in connection with the non-profit activities of the Cherokee County Humane Society.

The undersigned volunteer has carefully read and understands the foregoing and has the right and wishes to execute this instrument, and so acknowledges.
